Please review terms and conditions:

As an event organizer hosting a fundraiser to benefit the Canadian Cancer Society ("CCS"), I knowingly and voluntarily agree to abide by CCS's mission, vision and values, the rules and requirements outlined by the Canada Revenue Agency ("CRA") and the CCS Privacy Policy and the following terms and conditions.

I will not hold CCS accountable for any and all actions, causes of actions, claims, damages, losses, injuries, expenses, costs (including legal fees), charges and liabilities arising out of or in connection with the management and holding of this event.

I agree that no materials bearing any CCS logo will be printed or displayed for the event without CCS's prior approval. I also understand and agree that the official CCS logo by itself cannot be used for independent fundraising events.

I grant permission to CCS to use any photographs, video or other recording of the event, either submitted by me or another organizer or taken by a CCS representative for recognition or promotional purposes in any media and territory in perpetuity.

I agree to take full responsibility for planning, promoting, publicity, finding support staff and volunteers, management and execution of my event. CCS will not be named in, nor a signatory to, any contract on behalf of the event. CCS will not approach or solicit donors, volunteers, sponsors, supporters, or corporations on behalf of my event, nor will it provide contact lists. I also understand that CCS will not incur any cost on behalf of my event, either for funding or reimbursement. CCS will not be responsible for any financial losses or unsettled accounts, nor will CCS underwrite or insure my event.

I agree that I am responsible for obtaining all necessary licences, insurance, and permits and must conform to all government regulations in relation to the event. I understand that proof of licences, insurance, and permits must be provided to CCS upon request. The preceding also include lottery schemes which are defined as any scheme that has the following components - a prize, payment of a fee and a chance to win. Typically, these schemes include bingos, raffles, games of chance, 50/50 draws, break-open tickets and social gaming events held by charitable or religious organizations. A lottery licence is required to conduct a lottery scheme. Contact us before you proceed with this type of activity.

I agree that the event will not be aligned with any party, corporation or group whose mission is in conflict with CCS values or organizational priorities. This includes involvement in the following industries: tobacco, alcohol, pharmaceuticals, biotech and medical devices and equipment, complementary and/or alternative medicines or therapies, personal cancer screening or testing products, pesticides and herbicides, and artificial tanning. I agree that the event itself will not be affiliated with any of the aforementioned industries, and its execution shall be conducted in a safe and responsible manner.

I agree that all event promotions must clearly state the portions of proceeds to be donated to CCS, either by a percentage or dollar amount. I agree that no bank account will be opened in the name of CCS. I agree to provide proceeds from my event and submit them by cheque to CCS no later than 30 days after the event. I understand and agree that CCS reserves the final decision to issue any official tax receipts, which, if so issued, must be in accordance with CRA guidelines.
